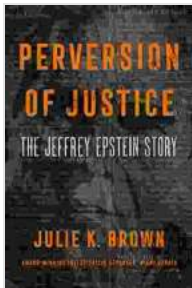

Epstein's Early Life and Career

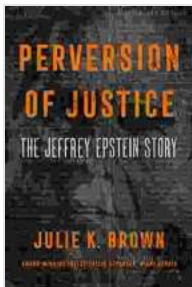
